

# AMITY COLLEGE - AUBURN SCHEDULE OF FEES 2019

## TUITION FEES

1. A Non-Refundable Application Fee of \$100 is payable with each student application.
2. A \$250 Enrolment Fee (non-refundable) must be paid upon acceptance of enrolment offer.
3. A Security Bond of \$1,000 applies per student with maximum \$2000 per family. The security bond is payable upon enrolment and will be refundable when the student leaves the school, provided there is no debt owing to the school. The Security Bond will not be refunded if a parent decides to cancel, defer or withdraw his/her child/ren from the school within 12 months of acceptance of enrolment offer and the completion of a full year's study at the school.
4. **New Enrolment Acceptance:** Successful applicants will be given an offer of enrolment; families have 2 weeks to accept the offer. At the point of enrolment, you must pay the Enrolment Fee, and Security Bond.
5. Amity College Tuition Fee is an **Annual Fee** which becomes due and payable upon enrolment or continued attendance to a new tuition year. For administrative purposes the fee is charged to Family Accounts over four terms (excluding year 12 students). School fees must be paid within the first two weeks of each term. Late payments may incur an administration fee.

### The Annual Tuition Fee for 2019 is:

*Tuition fees do not cover uniforms, textbooks, subject levies, excursions, transport fee, and optional accomplishments e.g. tutoring, sports registration or coaching. Excursion fees, subject levies and approved textbooks costs will be charged to your account.*

6. Fees are reviewed annually by the School Board.



## DISCOUNTS FOR PREPAID FEES

7. Amity College offers an early payment discount for tuition fees paid one year in advance.

## SIBLING (DISCOUNT) POLICY on TUITION FEES

8. A discount is allowed for siblings (brothers/sisters) who attend Amity College at the same time.
  - 30% for the second sibling
  - 50% for the third sibling
  - 100% for the fourth and subsequent sibling

## OTHER DISCOUNTS

9. **Alumni Discount:** A 10% discount will be available to all children of graduates who have completed year 12 at Amity College.

## STUDENT WITHDRAWALS

10. Where a parent or guardian of a student wishes to withdraw a student from the College a full term's notice, in writing, to the Principal is required. A full term's fee in lieu of notice will be charged if sufficient notice is not received.

## BAD DEBT POLICY

11. Where tuition fee is outstanding for a full term or greater, without any formal explanation or notice provided, the enrolment will be reassessed at the end of the school term. Where no acceptable debt repayment plan is agreed to, **student enrolment may be suspended or terminated.** Legal action will be followed to recover any unpaid fees; including placing the debt with a collection agency and listing the family account as default credit and any other legal action as deemed appropriate.

## VOLUNTARY PAYMENTS

12. Donations to the School Building Fund are tax deductible.
